Every OACIP Journal completes the [OACIP Criteria Form](#). Each journal's criteria form responses are made publicly available. This enables investors to make principled spending decisions and strategically fund programs that align with their missions.

Step 2: Consider your organization's capacity for support.

OACIP asks participants to make three-year commitments to fund OACIP Journals. Participants can pay annually or the full three-year commitment upfront. Cambridge Journal of Human Behaviour (CJHB) is a student-run, peer-reviewed, diamond open access journal. CJHB is the foremost interdisciplinary, international journal publishing exclusively the work of undergraduates researching human behaviour.



CJHB is seeking \$5,463/year for three years through OACIP so that the journal can maintain current operations, improve peer-review processes with a manuscript management software, and expand outreach efforts. With so few journals publishing the works of undergraduates and with its very low operating costs, every dollar donated to CJHB has an outsized impact on expanding the academic publishing opportunities available to undergraduates.

Canadian Journal of Bioethics

Revue canadienne de bioéthique

Canadian Journal of Bioethics | Revue canadienne de bioéthique (CJB/RCB) is the only bilingual (English and French), Diamond open access, non-profit, peer-reviewed bioethics journal in Canada. Hosted by the Bioethics Program at the School of Public Health of the Université de Montréal, the journal fills an important gap in the Canadian and international bioethics community, providing a space to publish high quality and thought provoking theoretical, conceptual and empirical bioethics research in diverse forms.



To sustain the journal’s continued growth, and to avoid burn-out of the Editorial team, additional funding is requested to move towards more paid editorial work. The CJB/RCB is seeking \$43,000/year for three years through OACIP to double the paid hours for the Scientific Director (who does substantial volunteer work), to hire a Coordinator (7h/week), to outsource page-setting (e.g., to a graduate student), and to begin providing modest honoraria to the Section Editors.

Financial Services Review

Financial Services Review (FSR) is the official publication of the Academy of Financial Services (AFS). The purpose of this double-blind peer-reviewed academic journal is to encourage research that examines the impact of financial issues on individuals. In contrast to the many corporate or institutional journals that are available in finance, the focus of this journal is on individual financial management.



In December 2022, the AFS Board unanimously agreed to move FSR to Diamond Open Access to maximize generation and dissemination of this research. AFS is proud to have partnered with the University of Georgia Libraries to host the journal. The journal is seeking \$23,000 a year for three years through OACIP to ensure that FSR can complete this transition to an open access platform and continue to thrive as the longest standing, independent journal in the field.

FS has been publishing high quality research on or inspired by Foucault for almost twenty years now, entirely open access. During the past two decades, it has established itself as the main venue in the anglophone world for scholars working on any aspect of Foucault’s thought and legacy, and as an essential tool for researchers all over the world to engage with each other’s work.

To remain faithful to its original mission and keep publishing first-rate research on Foucault completely free of charge for authors and readers, FS seeks an annual funding of \$34,500 for three years through OACIP.

[Global Social Challenges Journal \(GSC\)](#) is a peer-reviewed, interdisciplinary journal published on a not-for-profit basis by Bristol University Press, which launched on our new Bristol University Press Digital platform in 2022. The journal aims to address urgent global social issues by facilitating thinking about positive new societal trajectories within an inter- and transdisciplinary forum and allowing different disciplines and fields to interact with one another. This is something difficult to achieve in more narrowly focused, discipline-based journals.



Bristol University Press seeks collective annual funding of \$71,775 for three years through OACIP to publish its new fully Open Access *Global Social Challenges Journal* under a Diamond model, from 2025 onwards. This will enable the journal to provide a funded infrastructure for its diverse community of authors, editors and readers in order to tackle urgent global social issues, and to support the UN's sustainable development goals (SDGs) in a truly equitable way.

HKS Misinformation Review

[HKS Misinformation Review \(HKSMR\)](#) is a new format of peer-reviewed, scholarly publication. Content is produced and “fast-reviewed” by misinformation scientists and scholars, released under open access licensing, and geared towards emphasizing real-world implications. All content is targeted towards a specialized audience of researchers, journalists, fact checkers, educators, policy makers, and other practitioners working in the information, media, and platform landscape. The journal publishes high-quality interdisciplinary research that examines misinformation from different perspectives, from its prevalence and impact to the effectiveness of possible interventions.



HKSMR is seeking \$201,563 per year for three years through OACIP to cover its annual costs. The expenses undertaken by HKSMR are primarily support staff time spent editing, soliciting and accessibility checking articles and research notes. The funds also serve to incentivize participation by field-expert reviewers in the “fast approach” to peer review, which is integral in an ever-changing landscape such as misinformation.

Observational Studies

Observational Studies (OS) is a peer-reviewed journal that publishes manuscripts on all aspects of observational studies. The journal was originally self-published and moved to the University of Pennsylvania Press in 2021. The target audience of the journal is statisticians, biostatisticians, econometricians, epidemiologists and data scientists who develop and apply novel statistical and causal inference methods for observational data.



OS is seeking \$25,370 per year for three years through OACIP to cover its annual costs. To address the number of high-quality papers it receives, the journal is expanding from two issues per year to four, which will require more support and time from the editorial office. Stakeholders' investments will provide external copy-editing services and editorial office support and will pay for additional publishing and marketing services from partner publisher, the University of Pennsylvania Press. Funds devoted to editorial office support will also help the editorial team build bandwidth to work with early career scholars and scholars working in a non-native language.

[Trans Asia Photography \(TAP\)](#) is an international refereed journal editorially based at the University of Toronto. Founded in 2010, it is the first and only open-access international peer-reviewed journal devoted to the interdisciplinary exploration of historic and contemporary photography from Asia and across the Asian diaspora. Bridging photography and area studies, the journal rethinks transnational and transcultural approaches and methodologies. By centering photographic practices of Asia and its diasporas, the journal explores diverse approaches to understanding structures that inform how we see and how knowledge by and about the visual is formed.



TAP is seeking \$29,025 per year for three years through OACIP to remain open access beyond the current term of the agreement between the editors and the journal’s publisher, Duke University Press (DUP). The editors’ grants are subject to funding priorities at the University of Toronto and will cease when the editors’ terms end after 2026. Because of these two factors, it is imperative that we begin now to obtain funding commitments to begin in 2025 at the latest.

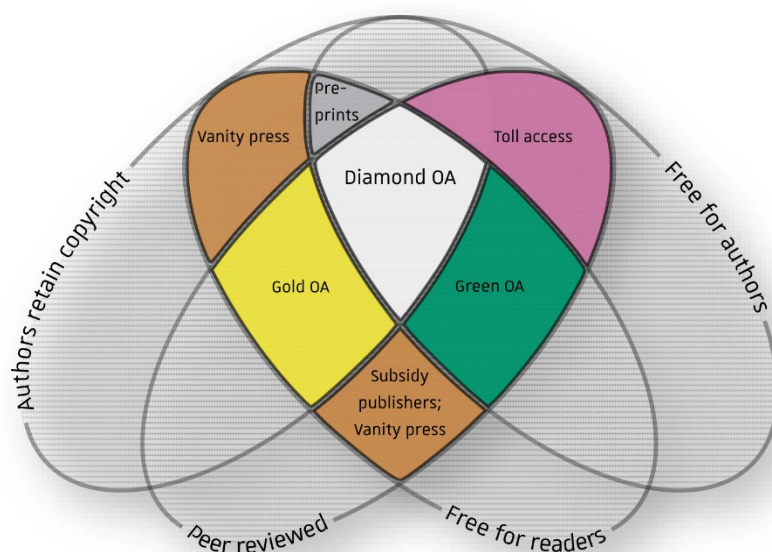

About Diamond Open Access Journals

Diamond open access refers to academic content (such as monographs, edited collections, and journal articles) published, distributed, and preserved with no article or book processing charges (APC/BPC) to either the reader or the author.

In 2021, it is estimated that between 17,000 and 29,000 scientific journals rely on a diamond open access model. They make up for 73% of the journals registered in the [Directory of Open Access Journals](#) and 44% of the articles, as their mean output is smaller than commercial journals. The Diamond open access model has been especially successful in Latin America-based journals (95% of OA journals) following the emergence of large publicly supported platforms, such as [SciELO](#) and [Redalyc](#).

In 2022, new national and international policies, such as the UNESCO recommendation on [open science](#), the [Budapest Open Access Initiative 20th Anniversary Recommendations](#), the [Action Plan for Diamond Open Access](#) promoted by the [cOAlition S](#), and the Horizon Europe-funded [DIAMAS Project](#) aim to support the development of non-commercial or community-driven forms of open access publishing.¹
